Variations to the Final Recommendations of the Land Conservation Council for the Rivers and Streams Special Investigation

Add the following note to Recommendation B1-26:

'Note 8: The exclusion of road upgrading does not mean that normal maintenance - particularly in relation to drainage and erosion minimisation on roads and tracks - is excluded from those roads and tracks that remain open for traffic.'

Replace Recommendation A9(q) with the following:

- 'A9(q)**
- (i) *(That) discussions take place between the relevant Victorian authorities with a view to investigating the provision of increased flows in low-flow periods (usually during the summer months) (see Note 2); and*
 - (ii) *if the socio-economic benefits/socio-economic costs are favourable following the investigations in (i), that further discussions take place between the relevant Victorian, New South Wales and Commonwealth authorities to consider this matter.'*
